 - 8. Participation sponsor amount and administration fees and corner fee
 - 8.1. Sponsorship to participating FDI enterprises include
 - 100% of rental fee for one standard booth: (not applicable to those receiving preferential twice in the previous trade promotion programmes);
 - 100% banner hanging fee;
 - 100% promotional networking, visitor invitations, transactions at the fair, supporting staff.
 - Total sponsor amount 6,576.4 USD
 - 8.2. Fees payable by the enterprises include:
 - 100% visa, meals, accommodation, traveling costs;
 - 100% cost relating to goods consignment;
 - Services used at the fair e.g. stand cleaning, etc. (if any);

- **8.3. Administration fee** payable to VITAS of 1,000USD/enterprise = 22,800,00VND
